## 2. REGULAR SESSION

The meeting convened at 12:25 pm in Regular Session joined by Martin Fox

- a. Report on closed Session-Future meetings of law library Board of Trustees to be held in Law Library at 710 Hamilton in Conference Room
- b. Approval of minutes of July 25 meeting. Errors regarding Judge Novak who was not present. Motion made by Wilkins to approve minutes with corrections to references to Judge Novak. Seconded by Schaiman. Approval by Canepa. Abstention by Judge Swope. July minutes with corrections approved and moved into record.
